Subject: discounted rates for municipal schools and daycare centers and canteen for state primary and nursery schools for the 2021/2022 school year

We wish to inform you that to take advantage of the discounted rates you must submit an application to the **Ufficio Rette** of the Municipality of Rimini by **15 OCTOBER 2021**.

ONLY for those in attendance of **municipal daycare centers**, the application for the discounted rates must also contain the supplementary declaration of **"additional information"** regarding consumption indicated within Annex 2 of the resolution of the G.C. n.342/2013 and successively, G.C. n.298/2019.

In case of non-submission of the application for the discounted rate (and the supplementary declaration of "additional information" – if needed), the maximum (ordinary) rate will be applied and any BONUS ("Mensa Bio" and "Al nido con la Regione") will not be applied.

The discounted rates are reserved for **minor residents** in the Municipality of Rimini with at least one resident parent with a *valid* ISEE MINORENNI of value equal to or less than:

- € 43.900,00 for daycare service;
- € 35.000,00 for other services (municipal nursery schools and school meals in state primary/nursery schools)

Eligible candidates who wish to request the special discounted rates and any further reductions such as those relating to the *"presence of other minors attending childcare services or a state primary school in the family unit"* or to *"family unit income deriving only from work as an employee"* (this second reduction applies **ONLY TO MUNICIPAL CHILDCARE SERVICES** and with ISEE not exceeding €25.000,00) **must submit the appropriate application**, in the following ways:

- 1) Directly through **the on-line portal** of educational services Sosi@home

- 1) Filling the form available on the municipal website (link: bit.ly/agevrettern) and sending it to the Ufficio Rette/Settore Educazione (together with a copy of a valid identity document) using one of the following methods:
